### **Executive Summary of Guidance**

#### ACADEMIC CONSIDERATIONS

- Districts are strongly encouraged to consider a return to in-person instruction if at all possible
- 5 clock hours of instruction are required
  - Direct Live Instruction
  - Recorded Instruction
  - Small Group Instruction
  - Independent Work (if assessed)
  - Individual Student Meetings/Conferences
- Appropriate staff planning & collaboration time
- Professional Development needs
  - Technology based platforms
  - Social Emotional & Mental Health


Note: A plan to transition back to remote learning should be developed in case of a return to Phase 3 All public and nonpublic schools in IL serving preK-12 must follow these guidelines.

#### **HEALTH & SAFETY CONSIDERATIONS**

- Require use of appropriate personal protective equipment (PPE), including face coverings
- Prohibit more than 50 individuals from gathering in one space
- Require social distancing be observed, as much as possible (3-6 ft between desks)
- Require that schools track symptom screenings and temperature checks by having individuals self-certify that they are free of symptoms before entering school buildings
- Require an increase in schoolwide cleaning and disinfection.

### **Our Return-to-School Plan**

#### **REMOTE LEARNING**

All students at home learning remotely

Phases 1 & 2: Teachers teaching from a remote setting

Phase 3: Teachers teaching from school setting

Established daily schedule, which mirrors Phase 4 schedule

Students learning using synchronous (whole group/small group) and asynchronous (independent) learning models

Students will participate in learning using Schoology, Seesaw (elementary), Zoom, etc.

#### **HYBRID LEARNING**

Students participating in a combination of in-school and remote learning

Students on an ABAB schedule for attending school

Students who are in remote learning will participate in class instruction using technology (Zoom)

Fridays will be remote for all students (following the daily schedule)

Students with additional identified needs will be given the opportunity to learn in school on all A and B days

Siblings will be scheduled to attend on same A or B days






Curriculum has been compacted to priority standards to teach to mastery. Committees worked throughout the summer to design both ELA and math.

### **Special Student Populations**

#### **Special Considerations for Special Education Students**

- All components of student IEP's (goals, accommodations) will continue to be implemented for students at school and to the greatest extent possible if they are learning in a remote environment
- Special education services are specific to each child's Individual Education Plan (IEP); therefore, specific information related to these services will be communicated to individual families
- The District will continue to conduct screenings, initial evaluations, and reevaluations for students in special education or suspected to be in need of services in both school and remote learning settings. Screening and evaluation procedures may be modified in a remote platform.
- Evaluations in which specific components could not be completed in due to COVID-19 restrictions will be completed at the start of the 20-21 school year.

### **Rationale for Model- Supporting Conditions**

- We believe in developing relationships and routines with students.
- We have space to social distance with half of the student population in attendance.
- We have had time to learn, provide resources, and plan for this experience.





### Safety and Health Sub Committee

### Symptoms & Temperature Checks

- COVID-19 symptom self-certification by ALL staff required
  - Recommendation once per trimester
  - Additional thermometers ordered offices and classrooms
- Parents will self-certify their child(ren)
- **CDC symptom checklist** will be used with **all visitors** 
  - Limits will be placed on non-essential visitors and volunteers allowed access to building
  - Activities involving external groups will likely not be allowed
- Isolation space has been identified for individuals with COVID-19 symptoms
  - School nurses will assist in new procedures



### Schoolwide Cleaning & Disinfection

- Following CDC and OSHA guidelines, extensive deep cleaning of all the facilities completed this summer (Following protocol from March pre-closure)
- Increased daily cleaning protocols throughout school when school resumes
- Emphasis on repeated cleaning of high-touch/high traffic areas throughout the day
- Teachers who move classrooms will sanitize shared areas prior to leaving and upon entering
- Cleaning of rooms will follow CDC guidelines
- Bulk supplies of sanitizer, disinfectant and PPE have been ordered
- Plexiglass barriers are being added to greeting counters and secretary desks
- Social distancing signage and hand washing reminders added throughout building



### Symptomatic or Confirmed Cases

- COVID-19 Symptomatic or Confirmed Cases
  - Symptomatic individuals will be isolated in identified isolation areas in each building
  - Contact Tracing will be implemented to identify those in close contact with symptomatic individual
    - Close contact is defined as within 6 feet of the individual for more than 15 minutes
    - Any individual coming in close contact with a person who tested positive for COVID-19 or is suspected of having COVID-19 should isolate at home and monitor symptoms for 14 days
    - Students required to quarantine due to a confirmed case of COVID19 will transition to a remote learning model during the quarantine period
  - Individuals will be sent home to monitor symptoms and will be encouraged to seek testing
  - Symptomatic staff and students who suspect they have COVID-19, whether they were tested or not, should stay home and not return to school until 72 hours have elapsed from resolution of fever without fever-reducing medication AND 10 days have passed after symptoms first appeared.



### **Arrival & Dismissal Procedures**

To prevent clusters of 50 or more people:

- Arrival and dismissal procedures will be modified to reduce student volume
- Students will enter the building through various doors based on grade level
- Directional signage added to hallways to facilitate traffic flow through
- Increased supervision at entrance and exit times



### Classroom Layout/Shared Spaces

- Building Administration creating scenarios (by classroom) with classroom capacity & layout
  - Seating configuration to maximum allowable space between students
  - Students to face same direction
  - Non-essential furniture to be removed from classrooms
  - Students Stay -- Teachers Transition (minimize student movement)
- Signage under development
  - Handwashing "how to" & "how often"
  - Scheduled bathroom breaks, supervision & safety tip reminders
  - Entrance and Exit routines
  - Arrows for the hallways, bathrooms, classrooms & common spaces
  - Mask reminders
- No communal supplies allowed



### **Shared Spaces**

#### • Restroom Procedures

- Goal: Limit the number of students in restrooms at one time
  - Schedule class trips and supervise accordingly

#### • Hallways

- Limits will be placed on number of students allowed in hallway at one time
  - Active supervision by all staff
  - Addition of hallway safety monitors

### • Drinking Fountains Wrapped

- Parents/guardians encouraged to send water bottles
  - Classroom supply for students without water bottles
- Use of lockers are prohibited
- Tables are being measured for social distanced and marked
- Capacity limits of shared spaces



### Lunch, Recess, and Field Trips

#### <u>Lunch</u>

- Students will eat in classrooms
- We will **deliver** lunches to **classrooms**
- Food Allergies are a high priority procedures under review with nurses

#### **Recess**

- K-5 outdoor recess
  - No more than 50 students will be at recess at a time
  - Playground equipment will be closed
  - Students will wash hands before and after playing outside
  - Face masks are not required outside IF maintaining 6 feet of social distance at ALL times

#### Field Trips will not be permitted



### Health & Safety of Student Populations

#### **Student Services**

- 504 Plans or IEPs may be revised, as needed on an individual basis, for additional health and safety requirements
- Physician recommendations regarding face covering accommodations will be addressed by each student's IEP or 504 Plan teams as needed
- Instructional Special Education
  - Social distancing will be adapted and modified in some special education settings coupled with disinfecting and hand washing practices
  - Mitigation of risk is paramount to staff and student safety
    - Needs of medically fragile students to be discussed with team
    - Additional PPE for these classrooms will be identified and provided



### Health & Safety of Student Populations

**Special Considerations for English Learners & Special Education Students** 

- Consideration of service model
- Pull-out services for groups of EL and Special Education students will be converted to smaller groups in larger spaces
- The use of remote instructional and related services may be considered both within and outside of the school setting as needed to reduce staff and student exposure to multiple peer groups
