Highlands Middle School Whole Child Award

Highlands Middle School is one of six schools in Illinois to receive the Whole Child Award. Mr. Papierski and the MS team received congratulations and applause for the efforts that led to this award.

### **Reports**

### Recommendation to Hire Elementary School Principal

Dr. Viniard reported there were nearly 70 applicants for the principal position. The selection process involved multiple interview rounds and the completion of performance tasks. Dr. Warke introduced the candidate selected to be the next Highlands Elementary School principal, Ms. Laura Magruder, and highlighted her many educational experiences. Ms. Magruder addressed the Board, expressing her thanks for the opportunity and noting the wonderful sense of community at Highlands. All present welcomed Ms. Magruder!

### Facilities: Analysis of Reorganization & Summer Projects

Mr. Hoefling reviewed the reorganization of the Building and Grounds department approved last spring and provided an analysis of the changes. The Maintenance Engineer job description was modified to bring HVAC maintenance in-house, two outsourced night shift custodian positions were eliminated, and one new district custodian night shift position was added. The department changes have realized significant cost savings. Mr. Hoefling praised Mr. Curtis Alsip, Maintenance Engineer, for the excellent job he is doing. He also highlighted the 2019 summer projects to include mechanical equipment replacement, roof repairs, and a lighting project in conjunction with a ComEd incentive.

### West Suburban Consortium for Academic Excellence (WSCAE) Report

Mrs. Beiermeister explained WSCAE provides extended learning opportunities to smaller districts that could not be provided otherwise. Highlands is one of fifteen school districts in the membership. Key

WSCAE activities in which Highlands students participate include: a Civic Weekend experience; a regional science fair hosted by Brookfield Zoo; an art show; a STEM class; and access to SAT and ACT assessments.
