**2023-24 School Calendar -** The Highlands School Board approved the 2023-24 school calendar at the December 20 Board meeting. Below are a few quick highlights:

- Inclement Weather Days Monday, January 8, 2024, and Monday, April 1, 2024, are student non-attendance days. If we cancel school due to inclement weather, students will attend on one or both of those days in lieu of doing a remote learning day or adding additional days in June. We aim for every student attendance day to be as meaningful as possible and believe these days in January and April will be more beneficial than a remote day or an additional day in June.
